GENERAL ADMINSTRATIVE AND REGULATORY CONDITIONS THAT APPLY TO DEALERS IN SEED COTTON/COTTON SEED/OPERATING A GINNERY/DEALING IN LINT COTTON AND EXPORT OF LINT/GINNERY CERTIFICATE

Pursuant to the provisions of the Cotton Development Act (Cap 30) laws of Uganda and more specially sections 5, 16, 20 and 21, CDO is mandated to prescribe terms and conditions among other duties, for registration of all persons/Organizations and Bodies involved/dealing in seed cotton, cotton seed, lint cotton, export of lint cotton and operating a ginnery in Uganda.

Arising from the said mandate, the said terms and conditions are stipulated as below:

i. While dealing in Seed Cotton and Cotton Lint, the dealers shall ensure that cotton is transported in fully covered trucks with non polypropylene water proof material to avoid spillage, spread of diseases, protection of cotton against weather conditions and maintenance of quality.

- ii. Dealers shall ensure that their buying centers/stores or their Agents are clearly marked and provide the following details; (1) name and official address of the Ginner, (2) Name and address of the Agent and (3) Valid mobile telephone number(s).
- iii. Use of polypropylene material for collection, transportation or packing of seed cotton or lint cotton is strictly prohibited as a mechanism to address cotton contamination in Uganda.
- iv. Dealers shall not deal in seed cotton produced in Segregated and Isolated areas unless with written permission of CDO.
- v. Stakeholders, that is, dealers in seed cotton, cotton seed, lint cotton and those operating a ginnery shall ensure that their agents abide by the conditions herein.
- vi. Other terms and conditions may from time to time be prescribed by CDO in writing as mandated by the law. Such terms shall be deemed to be part and parcel of the terms and conditions in this application.

CONDITIONS SPECIFIC TO GINNERY CERTIFICATION:

- i. Compliance to CDO Inspection Report recommendations on Civil, Electrical and Mechanical works
- ii. Presentation of Fire Fighting Systems certificate of compliance by, Certified Fire Service Company.
- iii. Presentation of Weighbridge and Weighing Certificate by Uganda National Bureau of Standards.
- iv. Compliance with laid down Quality control and Assurance Procedures.

Breach of any or all of the above conditions shall entitle CDO to revoke the registration certificate issued under these conditions.
