## LICENSE APPLICATION CHECKLIST,

## 1. APPLICATION;

## Submit;

Dully filled application form for relevant license/licenses as prescribed by the Lotteries and Gaming (Licensing) Regulations SI. No. 7 of 2017.

## 2. PROOF OF INCORPORATION;

Application only open to registered companies
i) Certificate of incorporation
ii) Memorandum and articles of association (activities applied for must be part of the objectives of the company).
(Purpose is to determine the registration status, shareholders/beneficiaries and objectives of applicant)

## 3. INVESTMENT LICENSE (FOREIGN OWNED COMPANIES)

Applicants who are more than $50 \%$ foreign are owned must attach an Investment License in line with the Investment Code Act.
(Purpose is to determine whether or not a foreign applicant is permitted to invest in the sector in Uganda in line with the law).

## 4. PROOF OF CAPITAL ADEQUACY

In line with the Lotteries and gaming (minimum capital requirements) Regulations, S.I No. 8 of 2017 the amounts specified and below in the schedule to the regulations and below shall be the minimum capital required in respect of each license.
(Purpose is to evaluate the capital adequacy of the company in line with regulations)

## Applicants to Submit:

i) Statement of Nominal Capital Form A1 of the Schedule to the Company's Act, 2012 (Newly incorporated companies).
ii) Form of Annual Return of a company with a share capital (Existing companies).
iii) Annual audited books of Accounts ( for existing companies)

## 5. GAMES AND RULES APPLICABLE

Submit detailed description of the games to be introduced and the rules applicable
(Purpose is to determine appropriate category of license and keep record of rules applicable to the games)

## 6. EQUIPMENT;

In line with the Lotteries and gaming (Gaming and betting machines) Regulations all Gaming and Betting machines must be registered in the National register of gaming and betting machines and they must comply with the prescribed technical standards for gaming and betting equipment.

## Applicants to submit

i) List of equipment to be used. Technical specifications of machines should be indicated. Submit manufacturer catalogues or narration by approved testing laboratories.
ii) Serial numbers, make/model and origin.
iii) Certificate of compliance of equipment issued by certified independent testing laboratory.

## 7. PREMISES;

In line with the Lotteries and Gaming (Licensing) Regulations SI. No 8 of 2017 premises for gaming, betting, bingo must be approved by the Board before use. Applicant should consult the standard for premises as detailed in regulations and below before identifying premises;

## Applicant to Submit:

i) Documentation proving ownership/ lease/ intention to lease of premises.
ii) Details of premises location indicating district, city, municipality or town council, plot, block numbers, street name and building where premises are located.
(Purpose is to ensure that premises and fit for purpose and compliant with law and regulations)

## Minimum Requirements For Gaming, Betting, Casino, Bingo, Pool Betting Premises.

All premises must be specifically approved by the Board before use and comply with the following minimum standard.
(a) The premises shall be situated only in a city, municipality or town council.
(b) Be of minimum size of 30 square meters;
(c) Permanent structure;
(d) Away from a school, a hospital, a market, a place of worship or government offices;
(e) Have accessible facilities of convenience and a common area for clients;
(f) Be able to accommodate all the intended activities within to avoid public nuisance. Clients, Notice Boards, TV screens, and other gaming equipment must all be contained within the premises and strictly not be visible from outside the premises.
(g) Have a strong-room for purposes of securing monies collected; and
(h) Have a notice board placed in a conspicuous place within the premises for the display of licenses, government notices, the rules of games promoted, telephone numbers of the Board, disclaimers regarding the effects of gambling and any other matter required to be displayed.
(i) Security measures to ensure security of clients and property in line with the police terror guidelines.

## 8. BUSINESS PLAN;

a) Clear statement of project objectives,
b) Applicants profile,
c) Planned Investment
d) Expected employment generation in Uganda.
e) Proposed implementation schedule and any other relevant information.
(Purpose is to know applicants objectives and investment plans as well as determine relevance and appropriateness of the planned investment to the overall objectives of the Lotteries and Gaming Act)

## 9. TAX REGISTRATION AND COMPLIANCE;

## Applicant to submit

i) Proof of tax registration
ii) Proof of tax compliance (existing operators and companies registered for more than one calendar year)
(Purpose is to determine the tax registration and compliance status of applicant)

## 10. DIRECTORS OF THE COMPANY;

## Applicant to Submit

i) Particulars of Directors of the Company.
ii) Proof of citizenship;
iii) Interpol clearance and declaration of criminal convictions
iv) work permit (showing relevant class) if foreign nationals
v) Detailed curricula vitae

## 11. KEY EMPLOYEES;

In line with rule 26 and 27 of the Lotteries and Gaming (Licensing) Regulations S. I No. 7 of 2017 following categories of employees must be licensed by the Board
a) Chief Executive or equivalent
b) Chief of operations or equivalent
c) Chief of accounts or equivalent
d) Managers of premises or equivalent and gaming floor managers for casinos or their equivalents

## For Key employee Licenses Submit.

i) Personal details of employee
ii) Curriculum vitae of employee
iii) For foreign nationals, Interpol clearance and work permits with relevant class should be attached.
iv) Declaration of any criminal convictions for theft, money laundering, fraud and any other convictions for crimes pertaining to moral turpitude.
v) Tax Identification Number registration certificate
vi) Proof of registration for Social Security

## 13. SECURITY GUARANTEE.
